In this text this method is pursued with rigor. Its interest is very great because the object, to which it applies itself, is the same Hegel's thought. Hegel has not picked only some essential lines of development, He picked also... lines of future possibility that continue to be valid today, when it seems to prevail the totalitarian administration of existence, and to inspire hope of liberation. This book presents a rigorous reading of works of young Hegel comparing his hypothesis with contemporary history and society. Between the studies of this type, this book is important for the full unification of a survey on the text with a research of useful categories for a modern sociology of religion, in order to avoid a sterile speculation and also a survey of social phenomena in which data eliminate the possibility of a global hypotheses indispensable problematic to give to the research a full significance.
